

RESOLUTION NO. 40-2022

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF SOUTH BAY, FLORIDA, AUTHORIZING THE USE OF AMERICAN RESCUE PLAN ACT FUNDS FOR THE PURCHASE OF ONE (1) KUBOTA SSV65 SKID STEER LOADER FROM RIDGE EQUIPMENT CO., INC. IN THE AMOUNT OF THIRTY-EIGHT THOUSAND FOUR HUNDRED TWENTY-FOUR DOLLARS (\$38,424.00); PIGGYBACKING THE FLORIDA SHERIFF'S ASSOCIATION COOPERATIVE PURCHASING PROGRAM CONTRACT NUMBER FSA20-EQU18.0; PROVIDING FOR AN ALLOCATION OF FUNDS; PROVIDING FOR AN EFFECTIVE DATE

WHEREAS, the City of South Bay ("City") desires to piggyback the Florida Sheriff's Association Cooperative Purchasing Program Contract number FSA20-EQU18.0 for the purchase of one (1) Kubota SSV65 Skid Steer Loader with associated ; and

WHEREAS, the price for a Kubota SSV65 Skid Steer Loader is Thirty-Eight Thousand Four Hundred Twenty-Four Dollars (\$38,424.00), including associated options 48" 5,500 Lb. Pallet Forks (Quick Attach \$1,204.00) and 68" Grapple Bucket with BOCE (\$5,411.00 AP-GB3068-21; and

WHEREAS, the City Manager has confirmed that the stated purchase is authorized as an allowable purchase utilizing the American Rescue Plan Act funds pursuant to the City's ARPA policy; and

WHEREAS, a purchase order for the one (1) piece of equipment is attached as Exhibit "A"; and

WHEREAS, the City Commission of the City of South Bay desires to authorize the City Manager to purchase the aforementioned vehicle utilizing American Rescue Plan Act Funds and execute documentation consistent with the intent of this resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF SOUTH BAY, FLORIDA, AS FOLLOWS:

Section 1. Adoption of Representations. The foregoing "Whereas" clauses are hereby ratified and confirmed as being true and the same are hereby made a specific part of this Resolution.

Section 2. Authorization of City Manager. The City Commission of the City of South Bay hereby authorizes the City Manager to piggyback the purchase of one (1) Kubota SSV65 Skid Steer Loader from Ridge Equipment Co., Inc. utilizing the Florida Sheriff's Association Cooperative Purchasing Program Contract number FSA20-EQU18.0. The City Manager is further authorized to take all necessary and expedient action to execute all necessary documents in order to effectuate the intent of this Resolution.

Section 3. Allocation of Funds. The City Commission hereby authorizes the expenditure for one (1) Kubota SSV65 Skid Steer Loader from Equipment/Vehicles Account Number: 001-151-64000.

Section 4. Effective Date. This Resolution shall be effective immediately upon its passage and adoption.
